All items awarded must be paid for in cash, cashiers check, or money order at Rio Dell City Hall 675 Wildwood Avenue, Rio Dell, CA 95562 within three business days of notification of award by the City of Rio Dell. All items awarded must be paid for at one time. There will be no splitting of payments.

Bidders will be notified by the City of Rio Dell within two business days of the close of the auction, for verification of bid award for their items.
